MEMORANDUM OF ASSOCIATION

- 1. The name of the Society shall be "The Conjeevaram Hindu Education Society" and it will hereinafter be referred to as the "Society"
- 2. [a] The address of the registered Office of the Society will be 6-7-8 Colla Chathram Street, Kanchipuram-631 502
 - [b] Date of formation of the Society (formerly called "The Conjeevaram Hindu Girls' School Union) registered as No:15 of 1911-1912 dated 14.12.1911 by the District Registrar, Kanchipuram within whose Jurisdiction the Office of the Society is situated: District Registrar of Societies, Sengaluneerodai Street, Kanchipuram 631 502

[c] The business hours of the Society will be between 10-00 a.m.

- The objects of the Society are:-
 - [a] To promote and advance the cause of education generally to encourage study in Art and Sciences, to teach students and give necessary facilities for research and development in English, Tamil, Hindi, Sanskrit and other languages.

 - [c]To establish and conduct educational institutions and undertake such activities as will be conducive to the imparting of Education in Tamil, Hindi, Telugu, English, Sanskrit and other languages.

1 Membership:

The General Body of the Society shall be constituted by the following two categories of members.

- 1. Patrons or Honorary Members and
- 2. Ordinary Members

2 Honorary Members:

The Governing Body of the Society at their discretion may invite a distinguished academician or administrator or educationist or other eminent persons in public life to join the Society as a patron or Honorary Member.

A person who is admitted as Honorary Member shall remain a member of the Society for a period of 5 years subject to Rule 5 of the Rules and Regulations. An Honorary Member will not be required to pay any subscription. He can be invited to advice and or attend the Governing Body and General Body meetings. Admission of Honorary Members shall be so regulated so that the total number of members of the General Body including the Honorary Members does not exceed thirty at any given time.

3. Ordinary Members:

any person subscribing to the objectives set out in the Memorandum above can be admitted to the membership of the General Body of the Society as ordinary Member provided that at least two thirds of the members of the Governing Body approve of

his admission. It shall be open to the Governing Body to reject any application for membership without assigning any reasons there for. Such persons admitted as members shall pay an annual subscription of Rs.50/- The payment of subscription can be made in advance for the year on or before the 31st March of every year.

Every member shall abide by the Rules and Regulations of the Society in force for the time being.

5. Disqualification:

Any member shall cease to be a member of the Society in the event of his.

- 1) Death
- 2) Becoming a person of unsound mind
- 3) Being convicted of a criminal offence
- 4) Resigning his membership and his resignation being accepted by the Governing Body
- 5) Removal from membership by a resolution of the Governing Body passed by a majority of not less than two thirds of the members present at the meeting if in their opinion the continuance of the person as member will be detrimental to the smooth functioning of the Society or furtherance of its object.

6) If he fails to attend three consecutive meeting of the Society without seeking leave of absence.

6. Election to the Governing Body:

- a) The admission and Management of the Society shall vest in and be conducted by a Governing Body with not less than 9 and not more than 15 members constituted in accordance with Section 15 of Tamil Nadu Societies Registration Act.
- b) All members of the Governing Body including the Office Bearers shall be elected at a meeting of the General Body of the Society. The members of the outgoing Governing Body shall be eligible for reelection when a new Governing Body is to be elected.
- c) Any vacancy that may arise in the Governing Body during its tenure period may be filled up by cooption by the Governing Body.

7. Office bearers:

The following office bearers shall be elected from among the members of the Governing Body.

President Vice-President Honorary Secretary Honorary Joint Secretary Honorary Treasurer Not less than 4 members

8. Members of the Governing Body including the Office Bearers shall hold office for three years from the date of their election to the Governing Body.

The term of Office of any member who gets appointed to the Governing Body in a vacancy arising in the intervening period shall be limited to the tenure of the Governing Body

- Resolutions and decisions at General Body Meetings shall be on the basis of majority of votes by members present with each the event of a tie in the tally of votes, the presiding officer will have an additional casting vote.
- No member who has lost his eligibility as a Member by virtue of the provision under rule 5 shall be entitled to be present at the meeting or vote personally or by proxy at any meeting.
- Special resolution will be passed by a majority of not less than 3/4th of the members of the Society entitled to vote as are present in person at a General Body Meeting of which not less than 21 days notice specifying the intention to propose the resolution as a special resolution has been duly given.
- Special resolution is required for amending objects, bye laws, additions or deletions thereof, change the name of the Society. Its dissolution or division or amalgamation.

SECRETARY:

The Secretary of the Society shall be the Officer of the Society
